Regular working hours: Monday to Friday from 06:00 to 22:00, Saturday from 06:00 to 14:00h

Overtime: regular tariffs are increased by 25%

Sundays and Holidays: regular tariffs are increased by 50%

If waste is collected without help of crew members, the surcharge is 10EUR.

Mandatory waste removal service is performed upon ship arrival and upon each 7 (seven) days the vessel remains at the port. Each additional waste removal service is performed on call.

Regular working hours: Monday to Friday from 06:00 to 22:00, Saturday from 06:00 to 14:00h

Overtime: regular tariffs are increased by 25%

Sundays and Holidays: regular tariffs are increased by 50%

C) Total price (TARIFF) for reception, shipment and disposal of waste

Total price for reception and disposal of waste is sum of TARIFF for mandatory waste removal service (A) and waste disposal TARIFF (B).

EUR is calculated according to the middle exchange rate of the CROATIAN NATIONAL BANK on the day of issuing the invoice.

Price (tariff) list is applied from May 01, 2021.
